### Objective of the fund

The objective of NIT Government Bond Fund is to generate best possible return with minimum risk, for its Unit Holders, by investing primarily in the Government Securities.

### Profile of Investment Managers

NITL is the largest asset management company of Pakistan with approximately Rs. 78 billion assets under management. The Board of Directors of NITL consists of representatives of leading financial institutions, prominent industrialists and nominee of Govt. of Pakistan. The Company has been assigned an Asset Manager rating of "AM2-" by Pakistan Credit Rating Agency, which reflects the company's very strong capacity to manage the risks inherent in the asset management business and the asset manager meets very high investment management industry standards and benchmarks. All Investment decisions are taken by the Investment Committee of NITL.

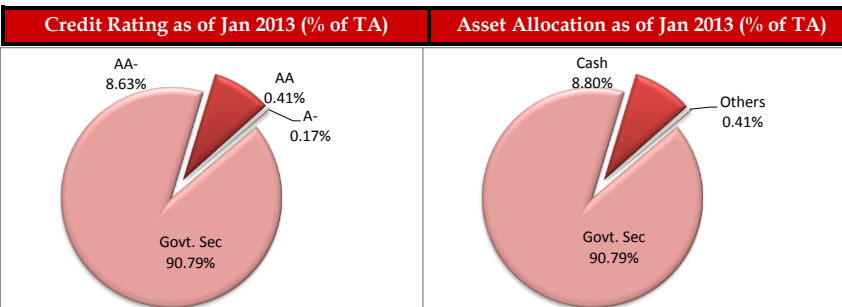
### Fund Performance Review

NIT Government Bond Fund yielded an annualized return of 12.50% for the month of January 2013 while its benchmark stood at 8.26%. The annualized return for the current year stood at 11.15% while its benchmark was 9.08%.

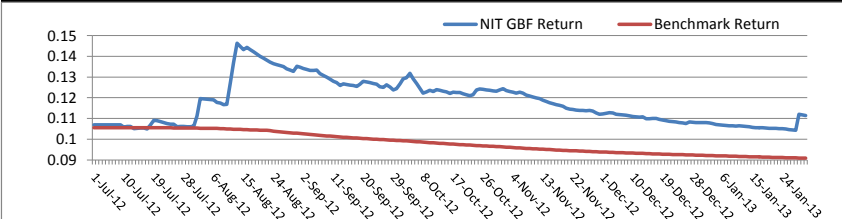
The Consumer Price Index (CPI) for the month of January increased to 8.07% year on year up from 7.93% in the previous month. A surprising increase in CPI has led market participants to expect the SBP to change its stance towards continued policy of monetary easing and hold Discount rates in this month's Monetary Policy Statement. SBP in its Annual report has projected inflation figures for FY12 in the 8-9 percent range.

On the money market front, SBP conducted two T-Bill auctions during the month. Cut-off yields at the end of the month stood at 9.0942%, 9.1645% and 9.2553% for 3, 6 and 12 months respectively.

The fund investments in Government Securities are about 91% of total assets mainly comprising of Treasury Bills while the remaining is in the form of cash and other assets. NIT GBF continues with a weighted average time to maturity of its portfolio of 160 days.
