Objective of the fund

The objective of NIT Government Bond Fund is to generate best possible return with minimum risk, for its Unit Holders, by investing primarily in the Government Securities.

Profile of Investment Managers

National Investment Trust Ltd. (NITL) is the first and the largest Asset Management Company of Pakistan, formed in 1962. Further to cater to the matters relating to investments in NIT and day to day inquiries/issues of its unit holders, a state of the art Investors' Facilitation Centre is also in place. The Company has been assigned an Asset Manager rating of "AM2-" by PACRA, which reflects the company's very strong capacity to manage the risks inherent in the asset management business and the asset manager meets very high investment management industry standards and benchmarks. All Investment decisions are taken by the Investment Committee of NITL.

Fund Performance Review

NIT Government Bond Fund annualized return for the month of January was 8.27% against its benchmark return of 8.70% while year to date return for the fiscal year stood at 6.79% p.a. against its benchmark return of 8.53% p.a.

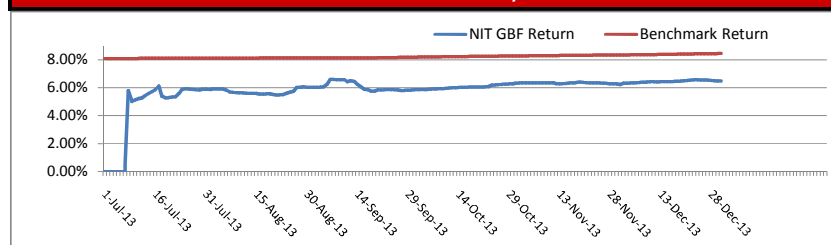
The Consumer Price Index (CPI) for the month of January reduced significantly from 9.2% to 7.9% year on year over the previous month. Reduction in inflation was anticipated Persistent decline in food inflation primarily helped in containing overall inflation. Inflation has eased since the recent high of 10.9% in November 2013.

Treasury Bills auctions during the month saw bulk of the participation in the 3 month papers. Cut off yields for the 3 and 6 months paper stood at the same level of 9.9564% p.a and 9.9791% p.a respectively as compared to previous auction. Participants also took positions and invested in 12 months paper for which cut off yield was 9.99% p.a.

The fund remains invested in Government Securities by about 97% of total assets mainly comprising of Treasury Bills while the remaining is in the form of cash and other assets. NIT GBF weighted average time to maturity of its portfolio stood at 83 days.
