Objective of the fund

The objective of NIT Income Fund is to generate competitive stream of return with moderate level of risk for its unit holders, by investing primarily in fixed income securities/instruments.

Profile of Investment Managers

All Investment decisions are taken by the Investment Committee of the respective fund.

Fund Performance Review

The Fund posted an annualized return of 5.76% p.a for the month of August against its benchmark return of 8.05% p.a. The YTD return for FY19 stood at 6.12% p.a. against the benchmark return of 7.81% p.a.

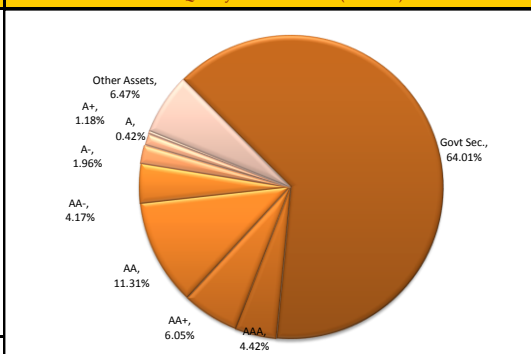
The Consumer Price Index (CPI) for the month of August increased to 5.84% versus 5.83% over the previous month. The 2MFY19 average CPI inflation now stands at 5.84% compared to 3.16% during the previous fiscal year.

Asset allocation of NIT IF by the end of month reveals that NIT IF had exposure of about 64% in Treasury Bills, around 23% of its total assets in TFCs, 4% in COIs, about 5% was invested in MTS and the remaining was in the form of cash and other assets. At the end of the month, weighted average time to maturity of the portfolio stood at 399 days.

TFC / Sukuk Holdings (% of TA)

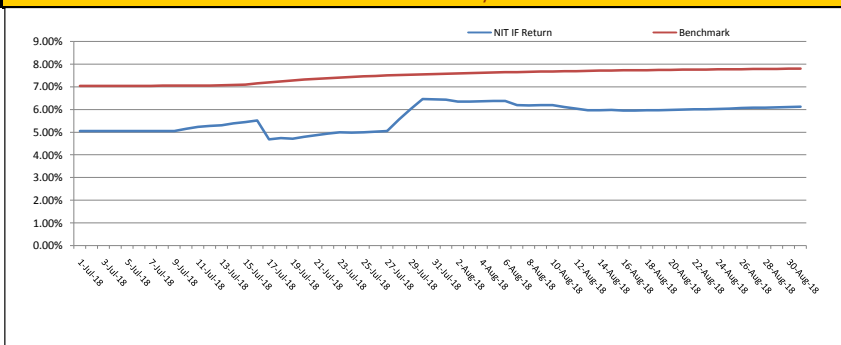
